The following are the agreement terms for vendor space at the FTLTOLI. As a Vendor, your acceptance of these terms shall constitute a binding agreement. It is agreed that each Vendor will abide by all terms listed in this agreement.

1. **FTL TOLI.** The word “FTL TOLI” as used herein shall mean the Ft. Lauderdale Taste of Little Italy, their officers, agents and any employees acting for it, in the management of this event.
2. **ELIGIBLE VENDORS.** The FTL TOLI reserves the right to determine whether any company or product is eligible under the standards for inclusion in the festival.
3. **ELIGIBLE PRODUCTS.** All products and services to be sold, offered or referred to during the FTL TOLI must be included on the Reservation Form. FTL TOLI reserves the right to exclude the sale of any product based on overall show presentation, or that are in conflict with exclusive contracts held by FTL TOLI with other Vendors (Examples: glow-in-the-dark products, t-shirts, etc.). Vendor will be notified in advance of any such exclusion and have the right at the time of the application to determine if they still want to participate.

4. **ADMISSION.** Gated event. Daily admission cost: \$10.00 Children under 12 are free.
5. **LIMITATION OF LIABILITY.** The Vendor agrees to make no claim for any reason whatsoever, including negligence, against FTL TOLI, its members, agents, employees or the owners of the Festival premises for loss, theft, damage or destruction of property or for any injury to Vendor or its employees while in the Festival quarters.
6. **BOOTH INFORMATION.** All Vendor materials must be kept inside their tent space, and the sidewalks and streets must be kept free of materials. Distribution of samples and literature is strictly limited to the confines of the Vendor's booth. Also, voice and/or music amplification must be kept to a sufficiently low volume so as not to disturb other vendors or attendees. Vendors agree to conduct themselves in a respectful, cooperative manner appropriate to the integrity of the attendees, fellow vendors and the show management staff.
 - a) The cost of renting a **10' x 10'SPACE** which includes a tent canopy from FTLTOLI, including set-up and tear down is **\$600.00** for the duration of the 3 day festival. *Please note for additional rental equipment such as sidewalks, tables, chairs, or lighting you can contact Denise at Panache Rentals at 561-833-2188*
7. **BOOTH ASSIGNMENTS.** FTLTOLI staff will assign booth location to Vendors. Consideration will be given to special needs, however we will assign according to the best interest of the show.
8. **VENDOR ADMISSION BANDS.** Vendor will receive 4 vendor staff wrist bands for each day upon vendor check-in.
9. **INSURANCE.** Insurance is the responsibility of the Vendor and is recommended. FTL TOLI is not responsible for replacement of lost or stolen goods. Vendors are responsible for obtaining their own general liability insurance for the show dates, including set-up and tear-down. Vendors will indemnify FTL TOLI for claims/suits arising between Vendors and attendees regarding exhibit rental.

*All booths must be staffed throughout the festival, and set-up 30 minutes prior to each show day opening or vendor may forfeit vendor space.

*Dismantling will begin on the final day, Sunday, March 5, 2017 starting at 8:00PM.

11. **SUBLEASING.** Vendors may not sublet their spaces, or any part thereof.
12. **FIRE AND SAFETY LAWS.** All federal, state and city regulation pertaining to fire and safety must be adhered to. All electrical cords must be grounded and be UL approved.

13. **COMPLIANCE WITH LAWS/STANDARDS.** Vendors are responsible for meeting all city/state resale-licensing agreements. Vendor is responsible for collecting Florida Sales tax and paying such tax to the State of Florida. FTL TOLI assumes no responsibility for any tax liability incurred by Vendor from the sale of any Goods at the Festival. Vendor further agrees to indemnify and hold harmless FTL TOLI from any tax liability Vendor may incur from the sale of any Goods at the Festival.
14. **PAYMENT.** Vendors must include all fees with registration form.
15. **CANCELLATION POLICY.** There are no refunds for cancellation due to rain or acts of God.
16. **RENTAL EQUIPMENT.** If additional equipment is needed you can contact **Denise at 561-833-2188.** **ALL RENTAL EQUIPMENT MUST BE PICKED UP BY SUNDAY NIGHT.**
17. This Agreement shall be governed by construed in accordance with the laws of the State of Florida.
